1. <u>Report of the Actuarial Audit by The Segal Group</u>: Ms. Nicholl and Mr. Strom presented the report of the full replication audit. Segal examined the actuarial valuations of the pension and health insurance funds for Fiscal Year ended June 30, 2014, including evaluating the data used in the valuations, replicating the valuations, and evaluating assumptions, methods and conclusions. In addition, Segal reviewed GASB 67 and 68 reports and performed a peer review of the 2005-2010 experience study.

Segal reported to the Committee that this was a clean audit. Segal told the Committee that "KTRS should feel confident that the results of the valuations are reasonable." Segal also noted that the valuations reflect the methods, assumptions and benefit structure of KTRS.

<u>Committee Action</u>: Upon motion duly made by Mr. Sanders, and seconded by Mr. Sutton, the Governance and Audit Committee voted unanimously to accept the report of the audit.

<u>Adjournment</u>: There being no further business to come before the Committee, and upon motion duly made by Mr. Sanders, and seconded by Mr. Sutton, and by unanimous consent of the Committee, Chair Sutton declared the meeting adjourned at 1:12 p.m.
