1. Discussion and Approval of Fee Renewals and Contracts through December 31, 2020: Ms. Gilbert presented information and staff's recommendations for renewal of contracts with UnitedHealthcare, UMR, Express Scripts, Know Your Rx Coalition and Aon Consulting.

<u>Committee Action</u>: Upon motion duly made by Mr. Green, and seconded by Mr. Underwood, the committee voted unanimously to recommend to the full Board of Trustees extending the contract with Express Scripts and the Know Your Rx Coalition from January 1, 2018 through December 31, 2020, as presented.

<u>Committee Action</u>: Upon motion duly made by Mr. Underwood, and seconded by Mr. Green, the committee voted unanimously to recommend to the full Board of Trustees the monthly fee of \$19,600 for consulting services and extending the contract from August 1, 2017 through December 31, 2020, as presented.

2. Discussion of Pharmacogenomic Pilot: Ms. Gilbert presented information regarding the

pharmacogenomic pilot project.

<u>Committee Action</u>: Upon motion duly made by Mr. Green, and seconded by Mr. Underwood, the committee voted unanimously to recommend to the full Board of Trustees approval of a master services agreement with Coriell Life Sciences for a pharmacogenomics pilot project as presented.

<u>Adjournment</u>: There being no further business to come before the committee, and upon motion duly made by Mr. Green, and seconded by Mr. Underwood, and by unanimous consent of the committee, Chair Harman declared the meeting adjourned at 11:35 a.m.
