# TEACHERS' RETIREMENT SYSTEM OF THE STATE OF KENTUCKY SPECIAL MEETING OF THE GOVERNANCE AND AUDIT COMMITTEE SEPTEMBER 20, 2021

## Minutes of Meeting:

After giving proper notice of a special meeting, and a quorum being present, Chair Hollis Gritton called the TRS Governance and Audit Committee to order at 11 a.m. ET, Monday, September 20, 2021. The meeting was conducted by live video teleconference.

1. <u>Experience Study</u>: Mr. Koebel and Ms. Bennett, both of Cavanaugh Macdonald Consulting, reported on the recommendations for the implementation of the experience study, including new tables.

Committee Action: Upon motions duly made and seconded, the committee unanimously voted to report to the board the actuary's recommended implementation of the experience study and the accompanying tables effective with the annual valuations for fiscal 2021; and, as further recommended by the actuary relating to the Retirement Annuity Trust, phasing in increases in additional contributions over five years consistent with the actuarial treatment of investment gains.

2. <u>Manager Contract</u>: Mr. Gritton announced in open session that the manager contract should be considered in closed session. Mr. Gritton stated that it was necessary to go into closed session to consider the report in accordance with KRS 61.810(1)(g).

Committee Action: Upon motion duly made by Mr. Collecchia and seconded by Dr. Patterson, the Governance and Audit Committee unanimously voted to enter closed session. Mr. Gritton announced that the record should reflect that there was a unanimous vote to conduct a portion of the meeting in closed session in accordance with KRS 61.810(1)(g). The committee entered closed session at 11:25 a.m. ET. TRS stopped the public broadcast during the closed session portion of the meeting.

TRS resumed the public broadcast of the meeting, and he committee returned to open session at 11:31 a.m. ET with no action being taken in closed session.

<u>Committee Action</u>: Upon motion duly made by Mr. Collecchia and seconded by Mr. Alverson, the committee voted unanimously to recommend to the board authorization to enter a new contract with Bellwether Enterprise.

<u>Adjournment</u>: There being no further business to come before the committee, upon motion duly made by Dr. Patterson and seconded by Mr. Alverson and by unanimous consent of the committee, Chair Gritton declared the meeting adjourned at 11:32 a.m. ET
