After giving proper notice of a special meeting, and a quorum being present, Chair Hollis Gritton called the TRS Governance and Audit Committee to order at 11:30 a.m. ET, Monday, March 20, 2023. The meeting was conducted in the TRS boardroom at 479 Versailles Road, Frankfort, Kentucky.

1. <u>Annual Renewal of Administrative Services Contracts</u>: Mr. Wampler reported to the committee on the proposed renewal of service provider contracts for fiscal year 2024.

Committee Action: Upon motion duly made by Mr. Collecchia and seconded by Mr. Alverson, the committee voted unanimously to renew contracts with vendors for fiscal 2024 as follows: Cavanaugh Macdonald Consulting; Blue & Co.; Ice Miller; McBrayer; Stoll Keenon Ogden; Williams and Jensen; Advanced Cleaning Services; SouthEast Printing and Mailing; MulloyBorland; and Vertosoft.

2. <u>Annual Renewal of Investment Experts Contracts</u>: Mr. Wampler presented information concerning the renewal of the contracts for the investment experts for fiscal 2024.

<u>Committee Action</u>: Upon motion duly made by Mr. Collecchia and seconded by Mr. Ross, the committee voted unanimously to renew contracts with the investment experts Bevis Longstreth and George Philip.

3. First Amendment to the TRS 403(b) Tax-Sheltered Annuity Program and Delegation of Limited Authority: Mr. Wampler presented the request to amend the Plan to clarify that the defined term "Beneficiary" relates to the supplemental benefit component of TRS 4 rather than the foundational defined benefit component of TRS 4. The recommended delegation would allow the executive secretary to make changes to the Plan to comply with law and other changes that do not materially increase the cost or change the benefits of the Plan. The delegation also

would require the executive secretary to report any such changes to the board at its next regular quarterly meeting.

<u>Committee Action</u>: Upon motion duly made by Mr. Collecchia and seconded by Mr. Alverson, the committee voted unanimously to recommend that the board adopt the first amendment and delegation of limited authority as described.

<u>Adjournment</u>: There being no further business to come before the committee, upon motion duly made by Mr. Collecchia and seconded by Mr. Alverson, and by unanimous consent of the committee, Chair Gritton declared the meeting adjourned at 11:44 a.m. ET.
