## TEACHERS' RETIREMENT SYSTEM OF THE STATE OF KENTUCKY SPECIAL MEETING OF THE INSURANCE COMMITTEE SEPTEMBER 18, 2023

## Minutes of Meeting:

After giving proper notice of a special meeting, and a quorum being present, Chair Boardman called the Insurance Committee to order at 12 p.m. on Monday, September 18, 2023. The meeting was conducted in the TRS boardroom at 479 Versailles Road, Frankfort, Kentucky.

1. <u>Approval of MEHP Rate for 2024</u>: Ms. Gilbert presented information concerning the recommended rate and supplement for 2024.

<u>Committee Action</u>: Upon motion duly made by Ms. Schneider and seconded by Mr. Underwood, the committee voted unanimously to recommend to the Board of Trustees a rate of \$207 per month for the 2024 TRS MEHP, which includes a combined UnitedHealthcare Medicare Advantage plan and Express Scripts Medicare Part D drug plan, for those retirees fulfilling the necessary service requirements.

2. <u>Approval of KEHP Supplement for 2024</u>: Ms. Gilbert presented information concerning the recommended KEHP supplement for 2024.

<u>Committee Action</u>: Upon motion duly made by Ms. McGown and seconded by Ms. Schneider, the committee voted unanimously to recommend to the board a health insurance benefit supplement for the Kentucky Employees' Health Plan (KEHP) up to \$885.30 per month in 2024 for those retirees fulfilling the necessary service requirements. This includes a KEHP administrative fee of \$8 per person per month (PPPM) for plan year 2024.

<u>Adjournment</u>: There being no further business to come before the committee and by unanimous consent of the committee, Chair McGown declared the meeting adjourned at 12:25 p.m.
