1. <u>Reports for Consent</u>: Chair McGown reviewed the draft minutes of the board's June 19, 2023, quarterly meeting and asked the board to act on the minutes.

<u>Board Action</u>: The board considered the minutes of the board's quarterly meeting held June 19, 2023. Upon motion duly made by Ms. Ball and seconded by Mr. Boardman, the board unanimously approved the minutes as written.

Chair McGown reviewed the draft minutes of the June 19, 2023, Governance and Audit Committee meeting and asked the committee to act on the minutes.

<u>Committee Action</u>: The committee considered the minutes of the June 19, 2023, Governance and Audit Committee meeting. Upon motion duly made by Ms. Schneider and seconded by Dr. Littlepage, the committee unanimously approved the minutes as written.

<u>Applications for Retirement and Annuity, Survivor Benefits, Life Insurance Benefits and Refunds</u>: Mr. Wampler reported to the board regarding benefit payments. Chair McGown asked the board to act on the report of benefit payments.

<u>Board Action</u>: Upon motion duly made by Mr. Gritton and seconded by Mr. Bruce, the board approved the applications for retirement and annuity, survivor benefits, life insurance benefits and refunds as reported.

<u>Interim Financial Statements</u>: The board considered the report on the Interim Financial Statements for the quarter ended June 30. The report was informational, and the board took no action on the statements.

2. <u>Report of the Investment Committee</u>: Mr. Siderewicz reported to the board concerning the activities of the Investment Committee and investment performance for the quarter ended June 30, and the quarterly meeting of the Investment Committee held on August 24.

Chair McGown asked for questions or comments and then asked the board to act on the report by Mr. Siderewicz.

<u>Board Action</u>: Upon motion duly made by Ms. Schneider and seconded by Mr. Boardman, the board unanimously accepted and ratified the report of the Investment Committee, including adopting the Proxy Voting Guidelines.

3. <u>Report of the Insurance Committee</u>: Ms. Gilbert reported on the special meeting of the Insurance Committee held on September 18, prior to the quarterly board meeting. The Insurance Committee recommended the board approve:

a rate of \$207 per month for the 2024 TRS MEHP, which includes a combined UnitedHealthcare Medicare Advantage plan and Express Scripts Medicare Part D drug plan, for those retirees fulfilling the necessary service requirements; and

a health insurance benefit supplement for the Kentucky Employees' Health Plan (KEHP) up to \$885.30 per month in 2024 for those retirees fulfilling the necessary service requirements. This includes a KEHP administrative fee of \$8 per person per month (PPPM) for plan year 2024.

Chair McGown asked for questions or comments and then asked the board to act on the report of the Insurance Committee.

Board Action: Upon motion duly made by Mr. Bruce and seconded by Mr. Underwood, the board unanimously accepted and ratified the report of the Investment Committee.

4. <u>Executive Secretary's Observations and Comments</u>: Mr. Harbin reported to the board on the operations of TRS. His report was informational, and the board took no action.

<u>Adjournment</u>: There being no further business to come before the board, upon motion duly made by Dr. Littlepage, seconded by Ms. Schneider and by unanimous consent of the board, Chair McGown declared the meeting adjourned at 1:14 p.m.
