Personalized Medicine Program for Retired Teachers of Kentucky

The Teachers' Retirement System of the State of Kentucky (TRS) offers a cutting-edge medication safety program under TRS' Medicare Eligible Health Plan (MEHP). This personalized medicine program uses DNA testing to help your doctor ensure your medications are safe and beneficial for better health outcomes for you. Unlike many genetic tests available today, this one does not look at all of your DNA and only focuses on the genes that help ensure the medicines you are prescribed work for you. Without this program, medications may be prescribed that will not work with your DNA. **For those who are covered under the MEHP, participating in this program is free and can be done from the comfort of your home.**

TRS has two partners in this program: **the Know Your Rx Coalition (KYRx) and Coriell Life Sciences (CLS)**. Together, TRS partners work with you and your physicians to best manage your medication therapies. Though participation is optional, we and TRS are confident that the results – which you'll be able to use the rest of your life – will benefit your health and could save you money.

A Real Personalized Medicine Story

Early in the program, a TRS member was prescribed a blood thinner after having a stroke. While on that blood thinner, the member had a mini-stroke. The member decided to take the DNA test, covered under TRS's health plan. Results showed the member had a DNA variation that impacted the blood thinner. The review with the pharmacist also found that the blood thinner did not interact well with the member's stomach medicine. The KYRx pharmacist worked with the TRS member and doctor to change to a different blood thinner, leading to improved health and well-being.

Program Success

More than 9,000 of your retired teacher peers have already taken advantage of this benefit by having their DNA tested. The results are amazing! As a result of this program:

- 100% of participants had at least one variant known to impact medication therapy outcomes.
- 66% had genetic risks detected in a currently prescribed medication.
- 14.9% decrease in hospitalizations.
- 6.8% decrease in emergency department visits.
- 1.9% decrease in outpatient visits.
- Direct medical charges were reduced by \$218.34 per member per month.



Your Privacy is Protected

As a participant in the TRS MEHP, you may receive communications from time to time that may include text, traditional mail, email, and interactive voice response. Each communication will feature the option to opt-out. Your information will not be sold to any third-party providers.

Your DNA information never will be shared with TRS and will not impact your TRS coverage or benefits. The DNA testing results are confidential and maintained securely, just like any other medical record. Coriell Life Sciences works with the Know Your Rx Pharmacy Coalition to provide an analysis of your DNA and will maintain your healthcare information in accordance with the Health Insurance Portability and Accountability Act (HIPAA). If you choose, you may allow your results to be used – with your identifying information removed – in medical research.
